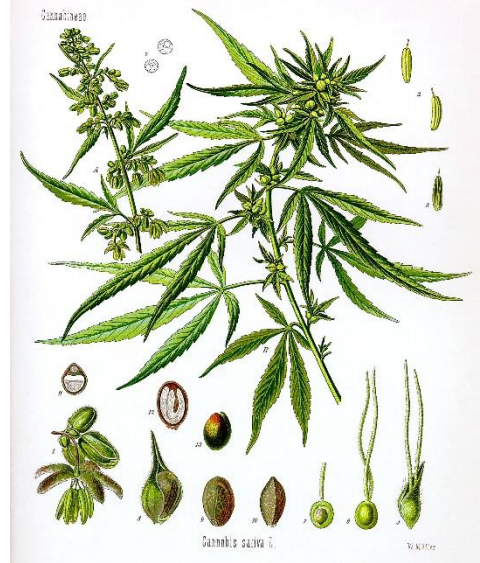
CBD OIL INDIANA

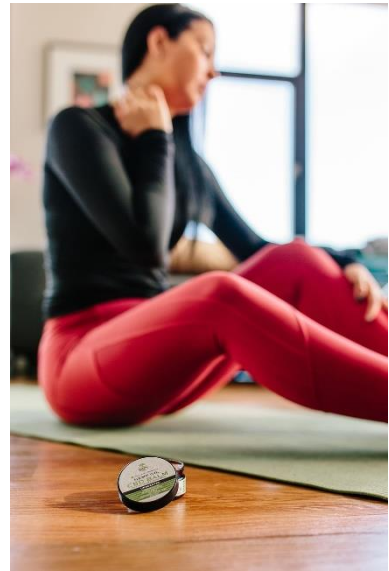


How CBD Works?
